## **GALIS Reports Folder Organization**



- Local Level: This folder contains local program reports that can be run by fiscal year for each program. The Local Level folder contains three subfolders.
  - Misc: This sub-folder contains local program reports that are not NRS reports or sign-in sheets.
  - NRS Reports: This sub-folder contains local versions of federally required NRS reports that can be run by fiscal year for each program.
  - **Reports for Review**: This sub-folder contains draft reports for programs to review and provide feedback.
  - **Sign-In Sheets**: This sub-folder contains sign-in sheets that local programs use for taking attendance.
- **System Level**: This folder contains state-level reports that can be run by fiscal year for the entire state.

NRS Reports This sub-folder contains local versions of federally required NRS reports that can be run by fiscal year for each program.

All Student AEL7001 Contact Information		Provides the name, phone, email, address, sex, date of birth, institutional use fields, and hours for students who have 0.25 hours and contact information in GALIS. Use this report to sort by different variables and follow up with students. Note: AdultOnlineREG@tcsg.edu is the default email address if the student does not provide one in the online registration form and should not be used to contact students.	
AEL7017 All Tests		Shows all tests taken by students with at least 0.25 for a given Fiscal Year, local program, and instructor. All students in this report either have a pre-test or post-test. Use this report to view information such as test form, test version, test subject, test score and EFL.	
Assessments AEL7013 and no Attendance		Provides a list of students who have assessments entered without attendance entered on the corresponding date. Use this report to ensure all students have attendance entered for their assessment dates. Excluded tests are not listed.	
AEL7026	Class and Sites Report	Provides information on Adult Ed sites by address, county, CRN room number, class times and days of week. The report also indicates which courses are Distance Ed.	
Class AEL7007 Summary List with Hours		Provides a list of all classes entered in GALIS with information including site, title, instructor, unduplicated enrollment, and a breakdown of classroom and online hours. Use this report to monitor in-person vs. online attendance hours by class to assist with data audits.	
AEL7018 HSE Test History Report		This report shows the count of unique students with at least 0.25 hours passing GED and HiSET subject tests. Completers may include students who completed either GED or HiSET prior to the report Fiscal Year.	
AEL7002 and Credentials		Provides a list of IETs by CRN. Page 1 provides a count of students, credentials earned, and students earning credentials by IET and overall. When you click each CRN, the report provides a list of students and credentials they have earned. Use this report to monitor IET enrollment and credential attainment.	
AEL7019 IET Follow-up Survey		The IET Follow-Up Survey collects real-time employment information for IET completers to evaluate the impact of IETs. This report includes IET students who earned a credential during the FY with their IET class and contact information. Programs should attempt to follow up with IET completers 6 months after they complete the IET students at least 2 times. Submit the IET Follow-Up Survey to OAE with the Local Program Data Quality Reports. Refer to the footer of the report for instructions on how to complete the survey.	

AEL0191	Post-Test Tracker: Most Recent Tests	Provides a list of NRS students with their most recent test information, hours, and EFL by instructor. Use this report to help identify students who may be ready to post-test.	
AEL7014	Secondary Goals	Provides a list of all students with secondary goals entered in GALIS and goal completion status, disaggregated by family literacy and IELCE as well. Use this report to monitor secondary goal data entry and progress.	
AEL7004 Staff Professional Development Hours by Local Program		Provides a list of staff members with professional development hours entered. When you click each staff ID, the report provides a list of professional development attended. Use this report to monitor accumulated staff professional development hours.	
AEL7005 Staff Professional Development Opportunity by Local Program		Provides a list of professional development events for each fiscal year with dates, state vs. local, number of attendees, and total hours. When you click each CRN, the report provides a list of attendees for each event. Use this report to monitor what professional development has been entered into GALIS at the state and local level and ensure accuracy.	
AELOO11	Student Attendance Hours: by Instructor, Class, and Student	Provides a list of all students with at least 0.25 hours by instructor and class with their hours, last date of attendance, and pre- and post-test status. The All Instructors drilldown page provides a breakdown of enrollment by ABE, ESL, and students who do not have a pre-test. The All Students drilldown page provides a list of students by total attendance hours in GALIS. Use this report to monitor enrollment and identify students for follow-up.	
AEL0298	Student Contact Information by Instructor	Provides the name, phone, email, and address information for students who have been assigned to a class(es). Use this report to follow up with students in your program. Note: AdultOnlineREG@tcsg.edu is the default email address if the student does not provide one in the online registration form and should not be used to contact students.	
AEL7015	Student Schedule Information	This report shows students by org, CRN, and Instructor. Use this report to find student class and contact information.	
AEL0003	Students with 0.25 Hours, No Pre-Test by Org	Provides a list of student IDs and hours for those who do not have a pre-test. Use this report to ensure students have valid pre-tests. If students have more than 12 hours and no pre-test, ensure the student's provisional EFL information is entered in GALIS.	
AEL7028	Students without VOEPB by Age	This report provides information on students close to or over 18 years old who need to submit a VOEPB and have at least 0.25 hours of attendance.

AEL0334	Table 4 WIOA Local - Measurable Skill Gains and Attendance by Instructor, CRN, Student	Provides a breakdown of MSG performance by instructor that programs can then drilldown by CRN and student. Use this report to analyze MSG performance by instructor for a specific date range. Can obtain a drilldown list of NRS students and their MSG status. This is the recommended report for analyzing program performance.

Can obtain a drilldown list of NRS students and individual status designations.
AELOO12	Table 7 WIOA Local - Adult Education Personnel by Function and Job Status	Provides a breakdown of active and inactive staff roles and part-time/full-time status. Can obtain a drilldown of all staff and their position, years of experience, certification, personnel type, and status.
